Routine Reports

- Attached are balance sheet and income statement reports as of December 17, 2020
- I am testing a cloud-based, cheap(er) accounting service (ZoHo Books).

Activity

- I have taken over the role of Treasurer from Mike Donnelly, effective October 6, 2020:
 - All records have been handed over
 - I have culled the boxes of records dating to the last century
 - All accounts have been changed to my address
 - The PO Box has been terminated
- We now have a debit card (for the checking account) to simplify payments.
- As expected, the most time-consuming issue is the management of the trailers (see below):
 - We have a plan to try to resolve the issues with the "Registered Owner" for trailers #2 and #6 (formerly assigned to Sam Hayden as caretaker)
- Very little other financial activity, due to the cancellation of most train shows (so no reimbursement requests from the modular groups).

Requests for action

- Can we transfer payment of the website hosting to the debit card (Anton) currently payed via PayPal? This simplifies accounting, due to the current need to transfer money to PayPal to cover the charges from the web hosting company with each payment.
- Trailers:
 - Should we skip paying registration fees until we need them? Is this legal?
 - Using my address, in the City of Seattle, seems to attract an additional \$80 fee. Should we use a different address for them? Considerations:
 - It is simpler if all mail comes to me, as Legal Owner and Registered Owner. This helps maintain complete records and to ensure timely payment.
 - But, other locations can dodge the \$80 fee. Is it worth it?
 - We have a spare trailer (#4). What should we do with it?
